Our focus on the young people and education in particular has really paid dividends.

   USA

- *Two* (2) marathon workshops in English Language and English Literature benefited *fifty* (50) fourth and fifth form students.
- *Seventy-one* (71) new mentors were recruited.
- For the second year in a row *Shari Brown*, won 1<sup>st</sup> prize in the essay competition, sponsored by Catalyst, with her essay entitled: "*It's All About Me*."

# Manager's Report 2009

The year 2009 was marked by the significant increase in the number of students in our program who excelled in their examination over the previous year. This was particularly note worthy in light of the economic down turn and its impact on the families and the community as a whole.

Many parents' source (s) of income was affected by redundancies in the public and private sectors. Parents migrated to other parishes and countries with hopes of finding some form of economic support leaving children/young adults to take care of their siblings and themselves. They were therefore left to deal with the possibility of not being able to complete their secondary/tertiary education.

That being said it created challenges for the Foundation to source enough funding to support the expanded demand for services that the above mentioned factors generated. Funding tertiary education was crucial as the number of students requiring assistance at this level surpassed our budgetary allocation.

In partnership with Grace Kennedy Limited, Grace and Staff held its' inaugural Education Run to benefit students returning to tertiary institutions. The race was a success as it raised over 1.5 million Jamaican dollars.

The Foundation provided relief for over 3000 clients; the largest support went to education assistance and health care for our most vulnerable groups. The demand for financial aid for persons from the rural areas who were unable to find work in Kingston and wish to return home increased.

The number of tertiary level student needing financial support increased in 2009. Within the inner city, once the children have achieved CXC exams or enter university, parents see this as an opportunity for the child to leave home or provide support for siblings, as it is felt that they are now adults. The parents have great difficulty understanding that on going support is still required after the child have achieved positive examination results.

Grace and Staff also provided administrative support for many community based organizations working within Kingston. The Foundation also facilitated venting and debriefing sessions for parents and students who were exposed to traumatic situations.

The Foundation could not have met all its objectives without the partnership and support of State Agencies and private sector groups who responded swiftly and positively to our referrals. We wish to acknowledge the contribution of our volunteers who in addition to giving financial resources, served on various committees.

Special thanks and appreciation must be extended to the subsidiaries: Grace Food Processors (Canning) and Grace Food Services for their continued support in providing snacks for the children at the Homework Centre and donations towards our Golden Age Baskets.

Last but not least we would like to thank Dick Kinkead Limited and Parents of Inner City Kids for their continuous participation in ensuring the success of our Programmes.

#### **ACCOMPLISHMENTS**

#### 1. YOUTH DEVELOPMENT PROGRAMMES

#### a. Education

Objective: To provide educational support for *four hundred* (400) secondary

students

To provide educational support for sixty (60) tertiary students

# **Achievements**

• *Three hundred (300)* students received educational support for the year 2009

- *Ten (10)* career talk sessions from various institutions were made throughout the year and students attended the ODPEM Career Expo
- *Fifty-nine* (59) students were successful in CXC, CAPE and A Level Examinations. (*See break down in appendix*)
- Chantelle Grant was accepted in the National Society of High School Scholars USA this afforded her the opportunity to identify scholarships overseas and network with her peers in the United States.
- *Chantol Dormer* received a scholarship to attend *Kettering University Michigan* for the summer of 2009 where she participated in pre-engineering and management courses.
- Forty-five (45) students took the SAT/PSAT Exams, the top score was 1819 in SAT to A- for PSAT.
- For the second year in a row *Shari Brown*, won 1<sup>st</sup> prize in the essay competition, sponsored by Catalyst, with her essay entitled: "*It's All About Me.*"
- *Four (4)* students participated in Job Shadowing at GFP Cannings & Group Finance. They acquired first hand knowledge of the role engineers play in production and management.
- *Seventy-one* (71) mentors were recruited for the mentorship program.
- Twenty-five (25) parents completed the data operations course level 1 and 2 at Garmex Heart Academy

# **b.** Homework Centre

Objective: To provide counseling service to three hundred and fifty (350)

students and parents at three (3) homework centres in Kingston.

# **Achievements**

- Two hundred (200) students registered for attendance at the LICK Homework Centre Tower Street.
- *Ninety-five* (95) students were registered at the Majesty Gardens and Barbican Homework Centres.
- Over eight hundred and fourteen (814) students and community persons sought counselling from the Foundation.
- Twenty-five (25) students of the Photography Club were taken on a Field Trip to visit a farm in Clarendon and markets around Kingston. The theme for 2009 was "Food Security: Bringing Good Food to Life".
- Students participated in (2) two motivational field trips to the Turtle Towers beach in St Ann and attended a Dance Recital at the University of the West Indies

#### c. Youth Summer Employment Programme

**Objective:** To provide summer employment for *eighty* (80) high school and tertiary students.

#### **Achievements**

- A database was established for persons seeking employment continues to expand however a number of persons have gotten employment as a result of our intervention
- Seventy-two (72) students gained work experience in various social agencies.

# 2. DEVELOPMENT OF COMMUNITY LEADERSHIP & CAPACITY BUILDING

**Objective:** To maintain social stability in the community of Parade Gardens, Majesty Garden and Bernard Lodge.

Provide training and exposure to new techniques in community planning and development parents and community leaders.

### **Achievements**

- PICK executives received training from Jamaica Business Development
   Center (JBDC) in book keeping, in how to write business plans and conduct meetings.
- PICK convened *twenty-four* (24) parent education meetings.
- The Foundation provided administrative support to *Four (4)* community groups including: Inner-city Marching Band, Victoria Foundation, Parade Gardens Citizens Association, and PICK.
- Supported four (4) fundraising events which were organized by community groups to raise funds for the purchase of equipment and instrument for unattached youth within the community.
- As part of the Grace and Staff Labor Day act ivies, a number of Grace Kennedy employees and their families participated alongside parents and students to give the LICK centre at Tower Street a face lift: cleaning and painting the building as well as repairing chairs and the roof.
- The LICK centre was selected as a venue for diagnostic testing for remedial students applying to HEART.
- Parents participated in the river of peace conference/march organized by Sistren Theatre Collective and Hanna Ford Smith.
- One hundred and twenty (120) parents attended a presentation on the pros and cons of abortion at Tower Street LICK centre.
- *Twenty-five* (25) persons were assessed for the Data Entry Level I & II course at Heart.
- *One* (1) HEART Trust Development Officer completed placement at Grace and Staff.
- *Six* (6) mediation sessions were convened for high risk youth in Majesty Gardens involve in an on going turf war.

#### 3. ECONOMIC ACTIVITY AND WEALTH CREATION

Objective: To provide loans, grants and business counseling up financing to establish *twenty* (20) micro businesses.

### **Achievements**

Of the 70 applications received small business funding

• Twenty (20) applications were approved for loans;

- *Fifteen (15)* received grants;
- *Twelve* (12) received business counseling
- And the remaining *twenty-three* (23) were referred to other agencies for funding as they were in need of larger funding support.

# 4. HEALTH CARE FOR THE COMMUNITY'S MOST VULNERABLE GROUPS: Indigent, Elderly & Infants

Objective: To support health relief for *three hundred and fifty (300)* Golden Agers, indigents and children in all.

# **Achievements**

Six hundred and sixty-one (661) Golden Agers, indigent and children in all received treatment, assistance with prescription and medical treatment.
 Surpassing our target by three hundred and sixty-one (361).

#### 5. CHRISTMAS OUTREACH

**Objective:** To bring Christmas cheer to *eighty hundred* (800) Golden Agers and school children.

# **Achievements**

- Seven hundred (700) food baskets were delivered to Golden Agers across Kingston and St Andrew.
- One hundred and fifty (150) children from Lakes Pen, Quarry Hill and
   Clifton received a Christmas Treat. Surpassing our target for the period.

# 6. VOLUNTEERISM

**Objective:** To increase staff participation by 50%

# **Achievement**

One hundred and ninety (190) employees from across the Grace Kennedy
Group of Companies taught and mentored the youngsters in the Grace and
Staff youth education program and increased their individual donations to the
Foundation.

# Membership Committee Report

For the Year 2009, several presentations were made at induction ceremonies and staff meetings to solicit new members, increase contribution and recruit volunteers to assist with the programmes administered by the Foundation.

As of December 2009 membership stood at *seven hundred and fifty-two* (752) employees from *twenty-three* companies across the group. This compared to *six hundred and forty-seven* (647) for the same period in 2008. The total amount contributed by employees for the year was \$3,202,035.00, which was matched by the company 2:1 ratio.

# **Projects Committee Report**

For the year 2009 the Foundation **received seventy (70) applications** for assistance with micro businesses mainly due as a result of the down turn in the local economy which propelled unemployment especially among women.

Of the 70 applications received, **twenty (20) applications were approved** for loans; **Fifteen (15) received grants**; **Twelve (12) received business counselling** and the remaining **twenty-three (23) were referred** to other agencies for funding as they were in need of larger funding support.

Traditionally women have always been the ones to access these loans; however, in 2009 there was a marked increase in the number of male applicants.

# **Education Committee Report**

2009 marked the 30<sup>th</sup> Anniversary of the Grace & Staff Community Development Foundation. It was a year to reminisce and celebrate the impact that the Foundation has had on the lives of countless young people. In 2009 alone, two hundred and forty-five (245) high school students were assisted including twenty-six (26) sixth form students. Funding was also provided for fifty-five (55) students attending tertiary institutions such as the University of the West Indies, the University of Technology, Jamaica, the Maritime Institute and Shortwood Teachers College.

The continued growth in the Foundation's education programmes and the marked improvement by the students each year has stretched the finances of the Foundation. Initiatives such as the GraceKennedy Education Run which was launched in 2009 and the Bursary Programme for tertiary students provided by the GraceKennedy Foundation are specifically geared towards funding these education programmes.

The Committee is happy to report that the external examination results for 2009 showed marked improvement over the previous year. We had four (4) students that took CXC subjects in forth form and successfully passed all exams taken; thirty-six (36) fifth form students took CXC exams, with twenty-three (23) passing five (5) or more subjects. The CAPE results were also excellent with Andre Ewan of Kingston College having the most outstanding results.

Congratulations to the Foundation staff, mentors, teachers at the Homework Centre and parents for their commitment to motivating these students to believe in themselves and work hard to achieve. We look forward to an even more successful year in 2010.

- The successful results obtained by students associated with the homework centres;
- The call for volunteers

These highlighted activities represent only a small portion of the substantial and invaluable work carried out behind the scenes by the hard working team at the Secretariat of Grace & Staff. The Community Relations Committee expresses appreciation to the Secretariat for their untiring efforts and significant contribution to community development. We also thank the volunteers who not only contributed financially, but also gave of their time and skills in furthering the work of the Foundation.

# Treasurer's Report

The Grace & Staff Community Development Foundation had a very successful year in 2009. The foundation recorded positive growth in all areas of its income stream. Key revenue growth areas were staff and company contributions, interest income, and fund raising.

Over 2009 the GOJ 6-months weighted average treasury bill rate reflected a decline to 16.8% from 24.45% in 2008, the BOJ foreign exchange selling rate depreciated by 11.3% to \$89.6002 (2008:\$80.4713) and the calendar inflation rate stood at 10.2% (2008:16.8%).

#### **NET SURPLUS**

The net surplus for the financial year ending December 2009 stood at \$3.73 million, up \$2.56 million, from \$1.17 million in 2008. The accumulated surplus stood at \$14.41 million as at December 2009 (2008: \$10.68m).

#### **INCOME**

Total income stood at \$34.10 million, inclusive of \$18.41 million in subvention from GraceKennedy to cover staff related costs. This reflected an increase of \$8.83 million year over year, when compared to the \$25.27 million recorded in 2008 (GK Subvention 2008: \$13.93m).

A disaggregation of total income reflected the following increases for 2009 over 2008:

Company and staff contributions grew from a combined \$8.0 million in 2008 to \$9.6 million in 2009, representing a 20% increase.

Interest income grew by \$1.08 million, from \$1.91 million in 2008 to \$2.99 million in 2009. This was due primarily to the prevailing relatively higher interest rate conditions, as well as, an increase in cash balances due to growth in fundraising and contributions.

Fundraising income reflected the most dramatic increase in contribution to income in 2009. Fundraising stood at \$1.99 million, up by 290% from the \$0.51 million recorded in 2008. The successful staging of the inaugural GraceKennedy Education Run on July 5, 2009 earned a net of \$1.8 million for the Foundation.

The GK Run came out of the need to raise additional income, amidst the growing educational success of students from the Foundation's programmes, with increasing numbers qualifying for tertiary education pursuits. The main objectives of the GraceKennedy Education Run are:

- To raise funds in support of inner-city education initiatives
- To raise public awareness as to the importance of education in community and national development

- To focus public attention on activities in downtown and to showcase its unique beauty
- To foster a healthy lifestyle and a spirit of good, clean, family fun.

By all accounts all these objectives were met during 2009.

#### **EXPENDITURE**

Total expenditure for 2009 stood at \$30.37 million, compared to \$24.09 million in 2008. Core expenditure, net of staff costs, stood at \$11.96 million, compared to \$10.16 million in 2008, reflecting a 17.6% increase year over year. Staff cost for 2009 and 2008 stood at \$18.41 million and \$13.93 million respectively.

The main area of increased expenditure was in educational expenses recording growth of \$1.76 million to \$5.68 million (2008: \$3.92m). This reflects the Foundations continued focus on educational programmes as a critical pillar of its community development intervention.

### **EQUITY**

The equity of the foundation now stands at \$18.23 million, which compares to \$14.37 million as at December 2008. This reflects a growth of \$3.86 million in 2009.

#### **SUMMARY**

The continued recession in Jamaica serves to increase the demand on the Grace & Staff Foundation's resources at a time when individuals and companies may be tempted to cut back. Added to this challenge is the matter of inflation and its impact on providing, at a minimum, the same level of services to communities. There will be continued need to strengthen the focus on growing membership, contributions and fundraising so as to support the growing need for the Foundation's services.

The Grace & Staff Foundation is committed, now more than ever, to continue to make its mark in the various communities that we serve. This is especially as the education system in Jamaica is challenged by lack of resources. We deeply believe that the future success and development of our country in inextricably linked to the strengthening of its human capital.

I would like to take this opportunity to express our gratitude to the directors, management, staff, subsidiaries and well wishers, who continue to partner with the Grace & Staff Community Development Foundation as it "builds a bridge of human care and understanding".
