Chairman's Report

USAID funds saw a marked increase in our ability to buy new equipment for all our Homework Centres, in particular computers, audio-visual equipment (including interactive whiteboards). Also new programmes that were targeted at the wider communities were able to be implemented. The programme will finish at the end of 2014 and final plans will ensure a smooth conclusion to this very valuable interaction.

The Western Union Foundation contributed to the expansion of our computer labs and we express our sincere gratitude to them and look forward to further cooperation. Seven commis chefs were also trained through assistance provided by the Western Union Foundation.

Microsoft contributed significantly in providing software licenses that have greatly assisted the continued compliance for our current and future needs.

The ICD Group has generously provided a building on Water Lane, Kingston, at a peppercorn rental. This will be developed into a STEM centre projected for opening in the fourth quarter of 2014. This facilitates a giant leap into the Science and Technology future for our students and others in the communities.

The performance of our students at all centres continues to improve at all levels of external examinations, and the analysis of our progress over the years is carefully monitored and discussed at the Board.

The Management and Staff of the Foundation are in constant demand for the inputs that are often required for guiding other social intervention programmes locally and internationally.

CHAIRMAN'S PRESENTATION

Mr. James Moss-Solomon gave an update on the activities undertaken in 2013 by the

Foundation and the status of the USAID grant. The following comments were made:

- (i) The 3 year period of the USAID grant would end in the latter part of 2014.
- (ii) ICD had donated a building on Water Lane to house the Science Laboratory & Education centre.
- (iii) The Science Laboratory & Education Centre would also be used for a robotics project.
- (iv) A launch ceremony for the USAID project was being planned for January 2014 with the intention to show what was being done in terms of the homework centres and community development.
- (v) The Chairman indicated that there were financial challenges during the year especially with regard to meeting school fees. Fortunately through the assistance of donors and ScotiaBank Foundation the fees were paid and none of the students were de-listed.

The Chairman on behalf of the Board expressed thanks and gratitude to Mrs. Madden and all the Grace & Staff employees for managing the business of the Foundation.

The Chairman also thanked the Board for guiding the process, and the parents and students for the difference they were making to their communities.

The Chairman indicated that he hoped to engage other companies to follow the path and so engage their communities.

GENERAL MANAGER PRESENTATION

Mrs. Madden began her presentation by expressing congratulations to the graduates of the work-force development team who had recently graduated as chefs and were the caterers for the evening. She extended appreciation to the Western Union Foundation which had sponsored the students.

The Management Report which was circulated was noted. The following comments were noted:

(i) Mrs. Madden highlighted some of the work of the Foundation which included the work at the homework centres, the adult literacy classes and behaviour modification programmes.

- (ii) Mrs. Madden gave an update on the Tower Street Centre as well as Majesty Gardens where it was indicated that violence was affecting students' attendance at the centre.
- (iii) Mrs. Madden highlighted that among the emerging issues was the identity crisis faced by young men and the plan for workshops with UWI and Fathers Incorporated to offer guidance.
- (iv) Mrs. Madden expressed congratulations to the members of the photography club. The following members were recognized:

- (v) Mr. Sweeny gave an update on the psycho-social issues being addressed by the Foundation.

PROJECTS COMMITTEE

- (i) It was noted that building on Tower Street donated by ICD would be converted to a multi-purpose science lab and stem education center.
- (ii) The building would also include computer labs.
- (iii) The USAID fund allocation was available for the construction and installation requirements but the building also needed to be refurbished.
- (iv) It was noted that discussions were being held with the Digicel Foundation and the hope was that they would come on board.

ROBOTICS PROJECT

Mr. Philip Alexander gave an update on the Robotics Project. He highlighted the need for the development of the robotics programme and the benefits of problem solving through robotic design. Mr. Alexander noted that there were challenges with resources and the availability of people to do the training.

GK EDUCATION RUN EXPANSION REPORT

Mr. Mark Anderson presented the GK Education Run (GKER) Expansion Report. The following comments were made:

It was noted that there was a 77% increase in registration for the 2013 staging of the GKER. It was noted that there was room for greater improvement and opportunity for growth across the group.

It was also noted that there should be more leveraging in communication and advertising through group companies.

Attendance at the centres experienced a tremendous increase as **USAID**, **Western Union and Microsoft** made their presence felt as they sponsored / contributed computers and software to the homework centres. This facilitated students in completing their homework effectively.

Youth Development Programs

For 2013, four hundred and nine (409) students received educational support (financial aid), the data is as follows:

- Grade 7 11: 260 Students
- Grade 12 -13: 55 Students
- Tertiary: 94 Students

Additionally, there were other students who were also assisted with books, uniforms and shoes.

Examinations (CSEC, CAPE, GSAT, SAT)

The student's performance at the CSEC and CAPE examinations was commendable (see Appendix pg 56-58). The GSAT students from Majesty Gardens, Savannah La Mar, Barbican and Spanish Town performed well and many were placed in traditional high schools across the urban and rural areas.

The educational support program also hosted SAT classes for eighteen (18) 5th – 6th form students. Also one student was awarded one full scholarship to VASAR University in the USA.

Health

Grace and Staff in Partnership with the Salvation Army Clinic Tower Street provided health support for Golden agers within the communities of Central Kingston.

In addition to those persons being treated at the clinic, an additional 143 persons sought assistance to fill prescription for golden agers and infants. These persons were suffering from asthma, diabetes, and hypertension and in a few cases HIV and cancer. Seven hundred and fifty (750) food baskets were distributed to golden agers across several inner city communities such as:

- Craig Town
- Majesty Gardens
- Payne Avenue
- Spanish Town
- Central Kingston

Psychosocial Support

The Table 4 below shows the number of students and community residents who sought counselling due issues related to death, lack of employment, incest, mental disorder, transitioning to new school and financial issues. Approximately 60% of these persons were referred to the PATH Program, Food For the Poor, Poor Relief and the Ministry of Social Security.

To ensure that students perform at their best, a number of support activities were implemented to motivate and provide soft skills. The activities done included but was not limited to career counselling /workshops, employment, resume writing and interviewing skills, photography club and computer camps.

Career Talks

Personnel from various professions were invited to present on various career options which are available to our students. This helped the students to make informed choices

when selecting CSEC subjects.

Summer Employment

Seventy-two (72) students from grades 10 through tertiary were given 4 weeks employment in social agencies. This allowed them to be exposed to several career options and provided some work experience.

Resume Writing & Interviewing Skills

During the period May – June 2013, students who wished to apply for summer employment and permanent jobs were given assistance in preparing resumes. They were also given practice and coaching to sharpen their interviewing skills.

Educational Planning

Students who were transitioning from primary to secondary and from secondary to tertiary were experiencing a level of anxiety which sometimes made it difficult for them to adjust or adapt to the new academic challenge. These students were given counselling and tips on how to cope with their new environment, this helped them to set achievable goals.

Motivational Activity - Photography Club

The theme for 2013 "More than a thousand words" focused on using photography to express and record stories. Twenty five (25) students benefitted from this event. The club entered JCDC competition and was awarded certificates of merit. Dianne Thomas of Spanish Town copped best picture followed by Cavelle Belnavis and Dave Richards who were placed 2nd and 3rd respectively.

Motivational Activity - Computer Camp

The computer camp is organized each year for students who are entering high school, but have little or no knowledge about computers. The students were given a hands-on course for two weeks where they learned how to use various software such as Microsoft Word, Excel and PowerPoint, and they all had to establish an email account. Twenty five (25) students benefitted from this program.

Work Force Development Programme

Seven (7) chefs and two (2) cosmetologists graduated from the Girls Town Heart Program. These students were sponsored by Western Union. After graduation four (4) of these students gained employment in the fast food industry, while the others are doing small businesses from home. Presently we are recruiting for general construction and electrical installation. This group will be financed by USAID funds.

Parents Meeting

Parents from the four (4) centres continue to meet monthly to discuss issues relating to their children and plan fund raising activities. They have attended several parenting workshops and strongly felt that the information garnered was most beneficial in their relationship with their partner and children. One mother remarked *"Since mi go di workshop, things change fi di betta between me and mi dawta."* Parenting education is available to all applicable persons that use the centres.

Additional Services Provided

Community residents and students continue to visit our offices to debrief and seek emergency assistance. These include

- Food and transportation (108 persons)
- Using Photocopiers & fax (161 persons)
- Computer use and printing (756 persons)

In other words, we have an additional 1025 persons receiving assistance from the Foundation.

Way Forward

 Provide educational and psychosocial support for three hundred (300) secondary and one hundred and fifty (150) tertiary students.

- Completing and administering the Science Technology Engineering and Maths (STEM) Centre by Jan 2015
- Strengthening the parent body to increase their effectiveness
- Create opportunities for networking/training for 25 community based organizations / non-government organizations
- To provide skills certification and training for 100 at risk youths and 50 community residents
- To provide health support for 500 golden agers
- Increase by 40 % and maintain 280 staff volunteer's participation in Grace and Staff activities
- Provide food and refreshments to one thousand (1000) golden agers and children through Christmas Outreach

Education Committee Report

2013 was a year of tremendous growth for the Foundation's education programmes. Thanks to a grant from USAID and Microsoft, the homework centres were refurbished and retrofitted with new computers, software and all the other amenities required for learning. The homework centres are now well equipped to assist the students and we expect to see their academic performances improve as a result of this generous investment by our partners.

The students performed well at the high school and tertiary level. Fifty-three students took CSEC exams in 2013. Shemara Rhoden of Wolmers Girls School and Dominique Whitely of Immaculate Conception High School did extremely well copping 9 ones each. Thirty-two students took CAPE Unit 1 & 2 exams. Immaculate student Sowhana Pommells did extremely well earning 4 ones and a two in her CAPE Unit One exams.

Our university students continue to perform at a high standard as well. The increased tuition costs have posed a serious challenge on our efforts to support the students financially. The team at the Foundation are to be commended for the many hours they have spent helping students to apply for grants, scholarships and student loans to ensure that they make it through university.

I wish to congratulate Mrs Madden and her team for their hard work, sacrifice and determination. They have worked tirelessly in the communities where we serve to give the young people a hope and a future.

Projects Committee Report

Major Projects:

New Science Lab/ Science-Technology-Engineering-Mathematics (STEM) Centre. WIHCON very generously offered an unused building on Water Lane (behind the ICD head office) for the project. This single storey 2,700 sqft building was previously used by CGM, and was emptied of all items in April of 2013. A three year lease agreement between G&S and WIHCON was signed commencing June 1, 2013, at a peppercorn rental of J\$3,000/mth.

Mrs Madden and Mrs Chance-Wilson have over the past two years conducted several outreach meetings with the adjacent communities, in order to build strong positive relationships with these communities and to ensure that they will fully support the STEM Centre. This continuing groundwork is needed to enable the lab to be operated in a sustainable and safe fashion. The 2014 Grace & Staff Labour Day project was the clean-up of the building and the adjoining area. The day was a great success.

A capital expenditure proposal to make good the building and fit it out for use as a multidiscipline science lab, with an adjacent computer lab, meeting room etc. was developed, with an estimate of expenditure of approximately J\$12 million. It was determined in early 2014 that the project could be nearly fully funded by a portion of the USAID grant. ColdAx, a local contractor with significant expertise in the building of science labs was subsequently engaged to fit out the lab.

The process commenced in June 2014, and is expected to be completed by early November 2014. The lab should be operational by November 2014. Included will be four separate lab stations for physics, chemistry and biology, for approximately 30 students; a computer lab

seating approximately 12 students, a study room for another approximately 12 students, a 3D printing room, and in the future a robotics room.

Discussions with MICO University, UTECH, SRC, the Ministry of Education and others have determined that teachers for the lab may come from these institutions. Further, the Ministry has expressed interest in using the lab as an extension of existing schools, which may assist in sustaining the operations.

Once the STEM Centre is operational, replication of similar centres will be evaluated. The use of mobile lab carts at other G&S homework centres will also be examined.

Statistical Evaluation & Analysis Committee Report

During the year 2013, the Statistical Evaluation and Analysis Committee conducted and analysis of the 2013 CXC and Cape Results among its students. This research primarily sought to determine if there were any significant changes in the 2013 results when compared to 2012.

The results of the exercise revealed the following:

<u>CXC</u>

- Once again, on average, 6 subjects were taken by students at this level (Minimum 1; Maximum 10)
- The average number of passes was 5. This was the same in 2012.
- When comparing the 2013 and 2012 pass rates for the different subject areas, 57% of comparable subject areas showed some level of improvement in 2013.
 - The most significant of these was Spanish which showed a 50% increase in the pass rate over the period.
 - Another 21% maintained a 100% pass rate. These subjects were:
 - Theatre Arts
 - Integrated Science
 - Home Management
 - Physical Education
 - Food & Nutrition
 - Technical Drawing
- Two subjects not attempted in 2012 were also attempted in 2013. They were:
 - Mechanical Engineering 100% pass rate; 3.00 average grade
 - Clothing & Textiles 100% pass rate; 3.00 average

 The results demonstrated that more students sat the general subject areas (Mathematics and English Language) and these subjects also showed an improvement in passes and grades. (Mathematics – 6% increase in pass rate from 53% to 59%; English Language 7% increase in pass rate from 74% to 81%).

<u>CAPE</u>

- Once again, on average, 4 subjects were taken by students at this level (Minimum 1; Maximum 6)
- The average number of passes was 4. This is a slight improvement over 2012 where this number was 3.
- When comparing the 2013 and 2012 pass rates for the different subject areas, 42% of comparable subject areas showed some level of improvement in 2013.
 - The most significant of these was Accounting Unit 1 which showed a 50% increase in the pass rate over the period.
 - The remaining 58% of subjects taken maintained a 100% pass rate:
- Six subjects not attempted in 2012 were also attempted in 2013. All of which received a 100% pass rate. These were: Food and Nutrition Units 1 & 2, Applied Maths Units 1 & 2, Law Unit 1 and Visual Arts Unit 1.
- The pass rate for Communication Studies improved by 12% moving from 88% to 100%.
 The average grade however declined from 2.69 to 3.07.

For 2014, the committee will continue to monitor activities and trends that will have an impact on the Grace & Staff Community Development Foundation.

GKER Expansion Report

The GraceKennedy Education Run 2013 was a resounding success raising J\$3.86 million which was a significant improvement over 2012 when just over J\$1 million was raised. These funds will help to make a world of difference in the lives of inner city youths, who can now look to an education they would not otherwise have been able to afford. Other metrics about the event are as follows:

- **Expenses:** the improved surplus was primarily achieved through the reduction in expenses while ensuring the quality of the race experience was not diminished.
- **Participants:** There was a 6% increase in the number of participants on race day moving from 3,358 finishers in 2012 to 3,569 in 2013.
- **Registrations:** There was a slight reduction in the number of registered persons moving from 4,780 in 2012 to 4,249 in 2013 or an 11% decline.
- **Teams:** there were 82 corporate teams and 24 non-corporate teams. The largest registered team with 172 persons was First Global Group.
- **Branding:** this area was strengthened which enhanced the overall visibility of the GraceKennedy brands and our partners at the venue and along the route.

The GKER is one of the main fundraising events for the Foundation and the event must continue to receive support at the highest level in the GraceKennedy Group. This is required to assist in mobilizing the support of other corporate entities in Jamaica to receive much needed cash. While we have been getting fairly good support from our partners over the years in the form of donations in 'kind', there is a need for greater cash donations. An improvement in cash contributions will help to improve the cash surplus as well as to strengthen the marketing communication for the event which would in turn result in greater numbers registering, especially large teams. As the needs of the Foundation increases each year, the event must deliver even better cash results. The following must be done to improve the event going forward:

- Develop creative and engaging experiences for participants to ensure the event becomes highly desired.
- Ensure our partners/sponsors continue to get good value for their contribution. The sponsorship categories were reviewed in 2013 with updated benefits to encourage greater support for the 2014 staging.
- Create greater linkages with the diaspora community in North America and Europe to solicit contributions
- The public relations for the event has improved over the years and this must remain an area of focus to build awareness about the work of the Foundation.
- An assigned marketing and sponsorship manager would help to improve the management and efficiency of this area.

The next GraceKennedy Education Run will be held on Sunday, July 6, 2014. We look forward to another successful staging as we strive to *Unleash Jamaica's Potential*.

Treasurer's Report

The year 2013 was quite an eventful year for both the Jamaica economy and the Grace & Staff Foundation. After a prolonged delay, the Government of Jamaica (GOJ) was successful in reaching an Extended Fund Facility Agreement (EFF) with the International Monetary Fund (IMF). This set up the possibility for additional financial support to become available, along with a schedule of quarterly quantitative and qualitative targets.

Early in the year in February, the Government initiated a second debt exchange - the National Debt Exchange (NDX). This resulted in outstanding GOJ domestic bonds being exchanged for lower coupon and longer tenure replacement securities.

The NDX exchanged bonds totalling approximately J\$860 billion, of which the Board approved the exchange of \$11.8 million of securities held by the Grace & Staff Foundation. The GOJ went on to pass successive quarterly IMF tests throughout 2013, amidst significant acceleration in the depreciation of the Jamaican Dollar. The Jamaican Dollar devalued by approximately 14.4% during 2013.

NET SURPLUS

The Foundation recorded a net loss of \$5.24 million for the financial year ending December 2013. This reflects a decline of \$6.42 million from the \$1.18 million surplus recorded for the year 2012. The accumulated surplus stood at \$9.21 million as at December 31, 2013 (2012: \$14.45m).

INCOME

Total income stood at \$57.51 million, inclusive of \$26.87 million in subvention from GraceKennedy Limited to cover staff and other related costs. This reflected a decline of

\$2.01 million year over year, when compared to the \$59.52 million recorded in 2012 (GK Subvention 2012: \$26.12m).

The following are the main contributors to the 2013 total income:

Company and staff contributions grew from a combined \$16.43 million in 2012 to \$16.80 million in 2013, representing a marginal 2.25% increase;

Other contributions declined by \$2.51 million, from \$3.33 million to \$0.82 million. Fundraising, sponsorship, donations and other income declined marginally from a combined \$12.08 million in 2012 to \$11.90 million in 2013.

Interest income recorded a slight decline due to the post National Debt Exchange (NDX) impact on market interest rates. Interest income recorded a decline of \$0.45 million, moving down from \$1.57 million in 2012 to \$1.12 million in 2013.

EXPENDITURE

Total expenditure for 2013 stood at \$62.75 million, compared to \$58.34 million in 2012. Programme and projects expenditure stood at \$26.99 million in 2013 compared to \$20.49 million for 2012, increasing by \$6.5 million. Administration expenditure stood at \$35.76 million for 2013, against \$37.85 million recorded for 2012, a decline of \$2.09 million. Included in Administration Expenditure are staff costs totaling \$15.32 million for 2013 (2012: \$14.30 million).

The main areas of increased expenditure were in *Depreciation* related to furniture, equipment and computers: increasing by \$3.74 million to \$3.90 million; *Project Assistance:* increasing by \$0.75 million or 9.27% to \$8.84 million (2012: \$8.09m) and *Educational Expenditure:* increasing by \$0.71 million or 7.44% to \$10.25 million (2012: \$9.54m).

EQUITY

The equity of the Grace & Staff Community Development Foundation as at December 31, 2013, stood at \$29.31 million, which compares to \$18.23 million as at December 2012. This reflects a net increase of \$11.08 million, with the primary impact on the capital reserve being a software donation of \$24.72 million received from the Microsoft Corporation on May 8, 2013.

SUMMARY

The Foundation remains in deep gratitude and appreciation for the support received from all its partners. I would like to express my personal thanks to the GraceKennedy Board and Executive Committee, as well as, the Board of Directors, management, staff, and other friends of the Grace & Staff Community Development Foundation for your support throughout 2013. Let us continue to *"Unleash Jamaica's Potential"* by *"Building a Bridge of Human Care and Understanding"* whilst *"Investing in our Youth"* through education. God's blessings.
